75% of Non-Refundable Cost Reimbursement for 75% the unused non-refundable pre-paid payments or deposits for your travel arrangements when you cancel your trip for any reason not otherwise covered by this policy.

Coverage is only available if you purchased this plan within 7 days of your initial deposit, you insured 100% of your travel arrangements up to a maximum trip cost of \$10,000, you cancelled your trip 2 or more days prior to departure, and specific departure date criteria are met.
